**Bill Davis called the meeting to order and the minutes were read by all, a motion to accept was made by Ken Mobley and a 2nd by Robert Wade.**

**Stevie Edwards gave the park report.**

- 1. Concession stand finish date is estimated for March 30th, 2012, just in time for special olympics.**
- 2. Sports complex is coming along, 500 trees were planted over the past couple of weeks and work on swales has begun.**
- 3. Basketball was successful this year, an overview of the year was given. A few problems occurred at the end of the season due to scheduling the awards program. Next year the end of the year awards will be worked out a little differently.**
- 4. Special Olympics will be held at the park on March 30th, 2012 and ramp will be added to the football field for wheelchair access.**
- 5. Nets on field one, the existing softball field may be extended to protect the new concession stand between Ricky M. Cairns football field and softball field 1.**

**Discussion was held about field use for upcoming sport seasons**

**(baseball and softball). Andy Gill asked when the middle school fields would be ready and if the park leagues would be able to use those fields after school practice is completed.**

**Mike Roberson requested that we have some type of rules for the concession stand use for the new concession stand at Ricky M. Cairns field and Calera Girls Softball, field 1. With all the different types of cooking equipment, a booklet should be placed in the concession stand showing the correct use of each appliance and cleaning instructions.**

**Ken Mobley brought to the attention of the members that a park director would be needed when the new facilities were completed. After discussion it was decided that Ken would email Cam Ward about information and research**

**Ken also suggested that projects could all be finished at the new park with a bond. Bobby Joe Phillips talked about a general obligation bond, but he also talked at length about the City's debt ceiling. Candace Roberson suggested that we discuss this with our city leaders and decide whether to put in the form of a motion to approach the council to check into a bond for the park.**
