# CHRISTMAS PARADE

## Parade Registration Information

**Parade Route:** Begins at Hwy 31 at the Calera Community Center and ends at the National Guard Armory. The judges trailer will be located at city hall.

**Decorations:** All entries must have Christmas decorations. Please don't enter your company vehicle in the parade without decorating as this is no fun for the spectators. The maximum float height from the ground is 13 feet 6 inches to clear traffic signals.

**Candy:** All entries should have plenty of candy to throw as you travel the parade route.

**Line Up Number:** You will receive an email indicating the area you are to line up in. You will be provided with a number once you've arrived at your assigned area on the day of the parade. Please display the number on the right side of your dash or vehicle. This is the only way the announcer will know which group to announce as you pass the judging station.

**Performances:** The time limit for any performance in front of the judging station is 1 minute. You could be disqualified from winning if you go over the limit.

**Restrictions:** Absolutely No live Santa's allowed! Santa will be riding on an Calera fire truck, and any other live Santa's will confuse the children.

**Sound System:** You must provide your own sound system. The City will not have any means to provide you with sound at the judging station.

**Float Rules:** All children must be seated on the float—Adults must be present and supervising children

**Driving Rules:** No reckless driving, No spinning of tires, Speed Limit—5 MPH, No popping of clutch, Only stop driving based on traffic flow or when in front of judging station

**Marching Rules:** Only stop marching when in front of the judging station

**Category Winners:** There will be one winner in each of the following categories – Best Holiday Spirit, Most Creative, and Most Entertaining. Winners will be notified a week after the parade.
